1. Age	The presumption is one's ability to adhere to social distancing and use of personal protection equipment is directly related to the age of the participants. 2. Duration of Activity	The presumption is the longer an activity runs the greater the likelihood of not maintaining social distancing, PPE placement, and general opportunities for exposure.	Less than 2-6 hours 6-24 hours Overnight

This includes responsibility for ensuring adherence to various guidance including use of PPE's, social distancing and monitoring of attendance.
