Re: 2021 Child Protection Reports

Attached are the 2021 Annual Child Protection Reports of the Archdiocese of Baltimore Independent Review Board (IRB) and of the Archdiocese of Baltimore, Office of Child and Youth Protection (OCYP). These are the fifth annual Child Protection Reports; they summarize the efforts of the IRB and the OCYP during reporting year 2021 (July 1, 2020 to June 30, 2021). The IRB was established in 1993 as a group of independent, interfaith, diverse, and primarily lay leaders to review actions taken by the Archdiocese in connection with allegations of child sexual abuse and provide counsel to the Archdiocese relating to its actions and policies for protecting children. The creation of the IRB was the direct result of the Archdiocese's own efforts to address the disturbing legacy of child sexual abuse, and to ensure the ongoing monitoring of decisions and initiatives designed to deal decisively with the scourge of child sexual abuse. The Office of Child and Youth Protection, established in accordance with the 2002 *Charter for the Protection of Children and Young People* is the office within the Archdiocese of Baltimore charged with implementing and coordinating efforts aimed at protecting children through screening and education and at providing pastoral outreach to victims of child sexual abuse. During a period of time that continued to be impacted by the Covid-19 pandemic, the OCYP has continued to value the oversight and recommendations of the IRB, which has remained active and engaged in promoting healing, restoring the trust of the faithful, and maintaining the highest standards to protect the children entrusted to the care of the Church.

In the preamble to his Apostolic Letter issued *motu proprio*, *Vos estis lux mundi*, Pope Francis states: "The crimes of sexual abuse offend Our Lord, cause physical, psychological and spiritual damage to the victims and harm the community of the faithful. In order that these phenomena, in all their forms, never happen again, a continuous and profound conversion of hearts is needed, attested by concrete and effective actions that involve everyone in the Church." We endorse this call for conversion, action, and involvement; and we see the Independent Review Board as an example of the action and involvement that is critical to the work of protecting children. We believe these reports reflect needed transparency and are a helpful tool to educate all about the ways to best protect the children entrusted to our care.

Effective June 30, 2021, the end of this reporting year, Hon. Joseph Murphy stepped down from his position as chair of the IRB after nine years of service. Judge Murphy was a long-time respected judge in the Maryland court system, previously serving as a Judge of the Maryland Court of Appeals and Chief Judge of the Maryland Court of Special Appeals. He also served as a prosecutor, including as Deputy State's Attorney for Baltimore City. Judge Murphy's wise counsel in pursuit of the values set forth in the Charter for the Protection of Children continued

to strengthen a culture of protection in the Archdiocese of Baltimore, and we are grateful for his dedication. Following Judge Murphy's departure, the board welcomed Dr. Jay Perman, M.D., Chancellor of the University System of Maryland and former President of the University of Maryland, Baltimore, as its newest chair.

**THE ARCHDIOCESE OF BALTIMORE
OFFICE OF CHILD AND YOUTH PROTECTION
2021 ANNUAL CHILD PROTECTION REPORT**

The Archdiocese of Baltimore is committed to providing safe and healthy environments for children and youth, to promoting the healing of victims of child sexual abuse, and to restoring and maintaining the trust of the faithful. This commitment is expressed in the Archdiocese of Baltimore's child and youth protection policies. These policies have been in place since the 1980s, and have been evaluated, strengthened, and disseminated broadly through the years. In 1993, the Archdiocese published written child protection policies and established an Independent Review Board. In 2002, the United States Conference of Catholic Bishops (USCCB) promulgated the *Charter for the Protection of Children and Young People* and Essential Norms which established a comprehensive set of procedures for addressing allegations of sexual abuse of minors by Catholic priests and deacons in every Catholic diocese in the United States. When the Charter and Norms were promulgated, the Archdiocese added to its existing child protection policies by implementing mandatory screening and training of employees and volunteers, as well as mandatory safe environment education for children. The Archdiocese has updated its child protection policies periodically, including most recently in November 2018, after input from the Independent Review Board and others. These policies, along with other important child protection information, can be found at www.archbalt.org.

Accountability is an essential component in restoring and maintaining the trust of the faithful. To that end, the Archdiocese of Baltimore (and its parishes and schools) submits to annual audits conducted by outside auditors selected by the USCCB to ensure compliance with the Charter. The outside auditors are changed periodically. Stone Bridge Business Partners conducted the most recent audit. The Archdiocese of Baltimore has been found to be in full compliance with the Charter every year, including for the Reporting Year covered by this report, namely July 1, 2020 through June 30, 2021.

In order to promote accountability and compliance with the USCCB Charter as well as with Archdiocesan policy, the Office of Child and Youth Protection reports to the Independent Review Board at regularly scheduled meetings throughout the year. In addition to these regular meetings, the Archbishop has directed the Office of Child and Youth Protection to create an annual report and requested that the draft report be shared with the Independent Review Board for its review. This document is the annual report for Reporting Year 2021, which primarily covers the information contained in the annual audit conducted by the USCCB for that time period regarding the Archdiocese's compliance with the USCCB Charter.

EDUCATION

The Archdiocese of Baltimore's safe environment training program (available online at www.virtusonline.org) educates Church personnel on preventing, recognizing, and reporting child abuse and neglect. All clergy, including bishops, all employees, and all volunteers having substantial contact with children at any covered entity of the Archdiocese of Baltimore are required to receive this training.

- Reporting Year 2021: 29,656 adults have received safe environment training, and as of the end of the Reporting Year are approved for employment or volunteering with substantial contact with children.

The Archdiocese of Baltimore's Office of Child and Youth Protection also conducts some in-person training for personnel in parishes, schools, as well as youth-serving organizations outside of the Archdiocese. This training is designed to supplement the required online training. In Reporting Year 2021, this supplemental training was conducted remotely for the faculties and staffs of Archdiocesan schools, for guidance counselors and school nurses. Additional remote training was also conducted for new employees of the Catholic Center; all new teachers, principals and youth ministers in the Archdiocese of Baltimore; deacon candidates; and seminarians beginning pastoral assignments. Pastoral staff and lay volunteers serving the Archdiocese's Hispanic community, attended remote training conducted in Spanish.

Family Life Catechesis, which includes safe environment education, is required for children in grades K-12 in Archdiocesan schools and parish religious education programs. The Archdiocese's Department of Evangelization assists schools and parishes in reviewing materials pertinent to safe environment education and child abuse prevention education. The resources are made available to parents and primary caregivers as well.

- In Reporting Year 2021: 35,527 children and youth received safe environment education.

In 2020, the Office of Child and Youth Protection, in collaboration with the Archdiocese's Office of Marriage and Family Life and Division of Catholic Schools, created additional online materials to be used by schools and parishes to support parents in imparting child abuse prevention education to children. These materials were used by Archdiocesan Catholic schools in April 2021, to supplement the safe environment curriculum taught in Religion classes, as part of Child Abuse Awareness Month.

SCREENING OF APPLICANTS

The Archdiocese of Baltimore is committed to healthy ministry and seeks to engage competent, qualified individuals to work with children. To protect children and youth, Church personnel are screened for their fitness to work with minors. This process requires obtaining references for all employees and for volunteers who work with children, and also the completion of criminal history screening for clergy, employees, and volunteers who have substantial contact with children.

- Reporting Year 2021: 4,795 clergy, religious, and employees had been cleared to work with children after submitting to a criminal history screening as of the end of the Reporting Year.
- Reporting Year 2021: 24,861 volunteers working with children had been cleared to work with children after submitting to a criminal history screening as of the end of the Reporting Year.

REPORTING OF ALLEGATIONS

The Archdiocese of Baltimore strictly complies with Maryland laws requiring the reporting of suspected child abuse to civil authorities. Under Maryland law, any person who has reason to believe a child has been subjected to abuse must report the suspected abuse to civil authorities, even if the potential victim is now an adult and even if the alleged perpetrator is deceased. If someone associated with the Church including clergy, employees, or volunteers in the Archdiocese of Baltimore, is suspected of committing abuse, Archdiocesan policy requires that the suspected abuse also be reported to the Archdiocese of Baltimore's Office of Child and Youth Protection at 410-547-5348 or to the Archdiocese of Baltimore's Victims' Assistance Line

staffed by a licensed social worker at 866-417-7469. The Archdiocese makes reports to the local office of Child Protective Services, the local office of the State's Attorney, local police, and the Maryland Attorney General.

Allegations of child sexual abuse are reported to law enforcement by the Archdiocese regardless of credibility. Allegations of child sexual abuse against Church Personnel are also reported to the Independent Review Board by the Archdiocese regardless of credibility. Anyone credibly accused of child sexual abuse, as determined by the Archdiocese and the Independent Review Board, regardless of whether the person has been convicted of a crime, is permanently excluded from ministry, employment, and volunteer service in the Archdiocese of Baltimore.

- In Reporting Year 2021, the Archdiocese of Baltimore did not receive against clergy any child sexual abuse allegations involving victims who are currently children.
- In Reporting Year 2021, the Archdiocese of Baltimore received allegations of child sexual abuse against two Archdiocesan priests who were in ministry at the time the allegations were reported. The allegations were reported to law enforcement, and the Archdiocese cooperated with civil authorities. The priests were suspended from ministry pending investigation.
- In Reporting Year 2021, the Archdiocese of Baltimore received an allegation of child sexual abuse against a member of a religious order who was serving in ministry in the Archdiocese of Baltimore at the time of the report. The allegation was reported to law enforcement, and the Archdiocese cooperated with civil authorities. The allegation was also reported to the religious order, who conducted an investigation. The priest is no longer authorized to serve in the Archdiocese of Baltimore.
- In Reporting Year 2021, the Archdiocese of Baltimore also received allegations of possible child sexual abuse against 15 priests, which involved alleged incidents from more than 40 years ago, deceased priests, priests previously removed from ministry, and/or clergy who were not identified. The 15 priests included priests of the Archdiocese of Baltimore, priests of other dioceses, and members of religious orders. Some allegations were reports from third-parties (i.e. not the alleged victim). All allegations were reported to law enforcement and the Archdiocese cooperated with civil authorities. Allegations against priests of another diocese or religious order were also reported to the respective diocese or religious order.
- In Reporting Year 2021: One volunteer serving in the Archdiocese of Baltimore was accused of possible child sexual abuse. The alleged abuse was reported to law enforcement, and the Archdiocese cooperated with civil authorities, who undertook an investigation. The volunteer is no longer eligible to work or volunteer in the Archdiocese of Baltimore.

OUTREACH TO VICTIMS

The Archdiocese of Baltimore remains committed to promoting the healing of survivors of abuse. The current practices of the Archdiocese include the following: The Archdiocese of Baltimore reaches out to those who have been harmed by Church personnel; The Archbishop, Vicar Bishops, and other Church leaders meet with and listen to survivors of abuse; The Archdiocese recognizes the importance of not only offering support to those who are abuse survivors, but to their family members as well; The Office of Child and Youth Protection offers

survivors counseling and pastoral services with the therapist of their choice, and coordinates a financial mediation program for survivors upon their request for monetary compensation in lieu of counseling. Mediations occur with a retired, non-Catholic judge in a non-adversarial forum where the survivor is represented by legal counsel and the Archdiocese apologizes for the abuse and offers survivors a personal meeting with the Archbishop if such a meeting would be helpful. Counseling assistance and mediated settlements are provided without regard to legal liability and regardless of how long ago the events occurred. Counseling assistance, mediated settlements, and related legal costs are paid through the Archdiocese's insurance programs.

- In Reporting Year 2021: The Archdiocese of Baltimore paid \$165,607 to provide counseling, therapy and other necessary medical costs for 35 survivors of child sexual abuse or their family members.
- In Reporting Year 2021: The Archdiocese of Baltimore paid \$198,000 in settlements with survivors of child sexual abuse, including 4 voluntary settlements through its mediation program for time-barred claims where all of the incidents occurred more than 30 years ago.

COMMUNICATIONS

In 2002, the Archdiocese of Baltimore voluntarily published a list of every priest or brother who had served in the Archdiocese and was known by the central offices of the Archdiocese to have been credibly accused during his lifetime of child sexual abuse, dating back to the 1940s. The list has been updated and includes the names of others credibly accused since 2002 and is accompanied by an explanation of how the list is compiled. The updated list is available on the Archdiocese of Baltimore's website, <https://www.archbalt.org/child-and-youth-protection/priests-accused-of-abuse/>. The website also includes the Archdiocesan Statement of Policy for the Protection of Children and Youth in the Archdiocese of Baltimore, its Code of Conduct for Church Personnel of the Archdiocese of Baltimore, and other relevant child protection documents, <https://www.archbalt.org/child-and-youth-protection/>. Contact information for reporting allegations of suspected child abuse to civil authorities and to the Archdiocese of Baltimore's Office of Child and Youth Protection is also included on the Archdiocese's website. The Archdiocese of Baltimore's Office of Child and Youth Protection communicates policies during required in-person presentations to new principals, teachers, catechetical leaders and youth ministers. The Office of Child and Youth Protection also provides training to faculty and staff at Archdiocesan parishes and schools as discussed more fully above.

COMPLIANCE

Since 2003, Archdiocesan policy has designated the pastor at each parish and the principal at each Archdiocesan school as the "Responsible Administrator," responsible for ensuring that all individuals serving in the parish or school are in compliance with the requirements of the Archdiocese of Baltimore's Child and Youth Protection Policies and Procedures, and ensuring that all required documentation is maintained.

Since 2003, Archdiocesan policy has required that each Responsible Administrator designate at least one Screening Coordinator to assist in ensuring that the parish or school is in full compliance with the requirements of the Archdiocese of Baltimore's Child and Youth Protection Policies and Procedures. The Screening Coordinator is required to maintain compliance records for the parish or school so that it can be verified that only those who have been screened and trained may work or volunteer with children.

- In Reporting Year 2021: 31 training sessions for Screening Coordinators were conducted.
- On-site visits of parishes and Archdiocesan schools by outside auditors and by Archdiocesan staff are conducted regularly to make sure that parishes and Archdiocesan schools comply with the Archdiocese of Baltimore's Child and Youth Protection policies and procedures.
- In 2021, the Archdiocese of Baltimore was again found by an outside auditor retained by the USCCB to be in compliance with the *Charter for the Protection of Children and Young People*. The audit period covered Reporting Years 2019, 2020, and 2021. The Archdiocese has been found in compliance every year since the audits were initiated. In 2021, in addition to reviewing records to confirm compliance with the Charter, the auditor interviewed separately 8 members of the Independent Review Board; the Archbishop; the Vicar General; the Chancellor; the Director of Clergy Personnel; Superintendent of Catholic Schools; the Director of Human Resources; the Director of Communications; the Director of the Office of Child and Youth Protection; legal counsel for the Archdiocese; and a number of pastors and staff from parishes across the Archdiocese.

OTHER FINANCIAL RESOURCES DEDICATED TO CHILD PROTECTION EFFORTS

- In Reporting Year 2021: The Archdiocese of Baltimore paid \$487,678 for its centralized child protection efforts, including salaries and expenses, training programs, and background checks that serve the Archdiocese's parishes, schools, clergy, employees, and volunteers. Salaries, expenses, and training programs of the Archdiocese's Office of Child and Youth Protection are part of the central budget of the Archdiocese of Baltimore supported by the cathedraticum paid by Archdiocesan parishes. Background checks are paid through the Archdiocese's insurance program.

INDEPENDENT REVIEW BOARD OF THE ARCHDIOCESE OF BALTIMORE 2021 ANNUAL CHILD PROTECTION REPORT

The Archdiocese of Baltimore established this Independent Review Board (IRB) in 1993 to review reports of child sexual abuse by church personnel and all actions taken by the Archdiocese to ensure the integrity of the Archdiocesan process for responding to reports of child sexual abuse. The Independent Review Board advises the Archbishop of Baltimore in his assessment of allegations of child sexual abuse and in his determination of a clergy member's suitability for ministry, and generally serves as a confidential consultative body to the Archbishop of Baltimore. Our role is described more fully in the policies of the Archdiocese (https://www.archbalt.org/wp-content/uploads/2018/11/aobDOCS-639208-v3RCA_Stmnt_Policy_2018_Revisions.pdf, at section 11) as well as in the USCCB *Charter for the Protection of Children and Young People* and Essential Norms (<http://www.usccb.org/issuesand-action/child-and-youth-protection/upload/Charter-for-the-Protection-of-Children-andYoung-People-2018-final.pdf>, at Norms 4 and 5).

The IRB is a group of independent, interfaith, diverse leaders. Our diversity provides wisdom and perspective to the Archdiocese as it responds to these important issues. Our 8 members are diverse in religion (5 Catholics and 3 non-Catholics), in gender (4 women and 4 men), in race (3 African-Americans), in religious state of life (7 lay professionals, 1 religious sister, and 1 archdiocesan priest who is a pastor), in professional backgrounds (including members with experience as a social worker, police officer, medical doctor, judge, attorney, teacher, head of school, parish priest, and government official), and other life perspectives (including individuals without children and parents of various-aged children who are going to or have gone to public, private, and Catholic schools).

Ever mindful of the importance of transparency, the Independent Review Board (IRB) has undertaken to issue this 2021 Annual Child Protection Report describing our activities during this reporting period (July 1, 2020 to June 30, 2021) so that the public might know of our continuing, vigilant work to promote the safety of children within the Archdiocese of Baltimore.

Meetings of the IRB are generally scheduled quarterly and last approximately 2-3 hours each. During the 2021 Reporting Year, the IRB met four times (in September and November of 2020 and in January and May of 2021).

Over the course of the four meetings held from during the 2020-2021 reporting year, the IRB reviewed 30 individual matters. The Archdiocese has committed to report to the IRB all allegations of child sexual abuse involving church personnel of the Archdiocese regardless of the age, details, or credibility of the allegation. Three of the matters reported to the IRB in Reporting Year 2021 involved alleged perpetrators whose names were unknown to the Archdiocese, because the perpetrators were not named by the people who reported abuse. In those matters, the name of the victim-survivor was also not reported to the Archdiocese. Eleven of the matters reported in Reporting Year 2021 were updates involving individuals who had already been reported to the IRB. Five of the matters reported to the IRB did not involve child sexual abuse. One of them involved alleged sexual harassment of a young adult, and three of them related to boundary issues with minors. The IRB provided advice to the Archdiocese regarding continuation of ministry, additional reporting or pastoral outreach, additional screening or training, investigation efforts, and further communications. Eight members of the IRB met individually with the outside child protection auditors appointed by the USCCB.

Archbishop Lori personally attended the meetings of the IRB during the reporting year. Detailed minutes of the IRB's discussion were kept and approved by the IRB at a subsequent meeting. When appropriate, at the discretion of the IRB, the IRB also meets in "executive session" without the presence of the Archbishop or Archdiocesan staff.
