

Rescue One Training for Life, Inc.

The Department of Catholic Schools, in conjunction with Tom Alban and the Office of Risk Management, has identified a medical supplies vendor, Rescue One Training for Life, Inc., that has a physician on their staff who is willing to act as the medical director for any of our schools that have been unable to identify a physician to serve as their medical director to meet the requirement of the general use epinephrine program. (July 17, 2019 letter from Chancellor, Jim Sellinger)

Request process update:

Effective 2022-2023 school year, we want to update the process if you are electing to contact Rescue One for your Epi Pen Medical Director Authorization and Rx. You no longer need to submit the completed enrollment packet to Rescue One to request their Rx and participation. Please just contact Lori Lewman (llewman@rescue-one.com) and provide your school name, address and Nurse contact info to request the Medical Prescription Certificate. Risk Management has agreed with Rescue One Training for Life, Inc. that it is no longer necessary for their folks at Rescue One to sign the Epi Pen policy document to help expedite the process.

Important Note: you will still need to forward the completed enrollment packet with Rescue One being named as the Medical Director to the Office of Risk Management along with a copy of the Medical Prescription Certificate from Rescue One to confirm their authorization. We will accept this without the previously required signatures on the designated section of the enrollment packet from Rescue One.

Dear School Presidents and Principals,

The Department of Catholic Schools, in conjunction with Tom Alban and the Office of Risk Management, has identified a medical supplies vendor, Rescue One Training for Life, Inc., that has a physician on their staff who is willing to act as the medical director for any of our schools that have been unable to identify a physician to serve in this role for the 2019-2020 school year.

It is understood that a number of our schools historically have been unable to offer the general use epinephrine pens due to the inability to identify a medical director. Rescue One Training for Life, Inc. through its staff physician will serve as the medical director of your program for a one-time fee of \$50.00.

For schools interested in this option, Rescue One Training for Life, Inc. has requested schools complete the paperwork on the Archdiocese website at <http://www.archbalt.org/risk> for general use epinephrine pens and then submit that information via email to Lori Lewman (llewman@rescue-one.com) for review and approval.

Once reviewed and approved, the form will be returned to your school for submission to the Office of Risk Management. Upon receipt by the Office of Risk Management, your final documentation will be reviewed and approved. Upon approval, notification will be sent by the Office of Risk Management that your school is approved to begin offering the general use epinephrine program.
